Holocaust Remembrance Day; Requiring the Governor to proclaim a specified day annually as “Holocaust Remembrance Day”; authorizing “Holocaust Remembrance Day” to be observed in this state’s public schools and be observed by public exercise as the Governor may designate, etc. Effective Date: 07/01/2025

Trusts; Revising how an authorized trustee may exercise the power to invade principal as an authorized trustee administering a trust; providing that property devised to or from a revocable trust which is devised, given, or distributed to a donee by a settlor during the settlor’s lifetime is treated as a satisfaction of devise to that donee if certain criteria are met; providing that homestead property transferred by one or both settlor spouses to a community property trust will not be treated as a change of ownership for the purposes of reassessing the property, etc. Effective Date: Upon becoming a law
