SPECIAL ORDER CALENDAR FOR WEDNESDAY, APRIL 23, 2025

CS/SB 738 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Burton—

Child Care and Early Learning Providers; Exempting public and private preschools from specified special assessments levied by a municipality; revising licensing standards for all licensed child care facilities and minimum standards and training requirements for child care personnel; requiring a county commission to affirm annually certain decisions; expanding the types of providers to be considered when developing and implementing a plan to eliminate duplicative and unnecessary inspections, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

SB 726 (SO) by Senator Ingoglia and others—

False Reporting; Providing that a person who misuses emergency communication systems is liable for the costs of prosecution and investigation; providing that a person who makes a false report to law enforcement authorities is liable for the costs of prosecution and investigation; providing that such persons are also liable for restitution if the false report involves another person who sustained injuries or property damage as a result of the false report, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably by the Committee on Regulated Industries; and reported favorably by the Committee on Rules

Compare to **CS/CS/HB 279(HC)** in the Committee on Rules

CS/CS/SB 656 (SO) by the Committees on Rules, Health Policy and Senator Rodriguez—

Health Care Billing and Collection Activities; Revising the definition of the term "extraordinary collection action"; authorizing licensed facilities to engage in an extraordinary collection action under certain circumstances, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Health Policy; the Committee on Commerce and Tourism reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

Similar to **CS/HB 547, 1st Eng.(HC)** in the Committee on Rules

CS/CS/SB 650 (SO) by the Appropriations Committee on Pre-K - 12 Education, the Committee on Transportation, Senator Leek and others—

Hazardous Walking Conditions; Revising the criteria that determine a hazardous walking condition for public school students, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and the Committee on Rules reports the committee substitute favorably

Identical to **CS/CS/HB 85(HC)** in the Committee on Rules

CS/CS/SB 584 (SO) by the Committees on Fiscal Policy, Education Postsecondary, Senator Garcia and others—

Young Adult Housing Support; Requiring each Florida College System institution and state university to develop plans for prioritizing the placement of certain students; requiring the Department of Children and Families, community-based care lead agencies, and housing authorities to take any action required by the United States Department of Housing and Urban Development to administer the federal Foster Youth to Independence initiative and other federal programs and vouchers; requiring the Office of Program Policy Analysis and Government Accountability (OPPAGA) to conduct a study of the barriers to housing faced by young adults who are homeless or were formerly in foster care, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Postsecondary; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 508 (SO) by the Committee on Rules, the Appropriations Committee on Pre-K - 12 Education and Senator Jones—

Family Empowerment Scholarship Program; Requiring private schools participating in the Family Empowerment Scholarship Program to provide specified information in writing to certain parents before their student's initial enrollment in the school; providing private school requirements relating to certain services, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/CS/SB 498 (SO) by the Committees on Rules, Banking and Insurance, Judiciary and Senator Grall—

Trust Fund Interest for Purposes Approved by the Supreme Court; Authorizing financial institutions to hold funds in specified trust accounts to be used for specified purposes; requiring such financial institutions to pay a certain minimum interest rate or dividend; requiring that the interest rate be at least a specified percentage; requiring a financial institution to submit a quarterly rate validation sheet and affidavit to the Chief Financial Officer attesting that it will pay a minimum certain interest rate or dividend; requiring that the affidavit attest that certain information is true and factual, etc. Effective Date: Upon becoming a law

CS/CS/CS/SB 462 (SO) by the Committees on Fiscal Policy, Regulated Industries, Transportation and Senator DiCeglie—

Transportation; Requiring counties to report certain information to the Office of Economic and Demographic Research annually by a specified date; revising provisions relating to the administration and financing of certain aviation and airport programs and projects; revising the bidding and award process for contracts for road construction and maintenance projects; revising membership of the governing body of the Greater Miami Expressway Agency, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 430 (SO) by the Committee on Education Pre-K - 12, Senator Simon and others—

Cardiac Emergencies; Revising requirements for instruction on cardiopulmonary resuscitation and the use of an automated external defibrillator; requiring each public school to develop a cardiac emergency response plan (CERP); requiring public schools, including charter schools, to have at least one operational automated external defibrillator on school grounds by a specified date, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Appropriations Committee on Pre-K - 12 Education reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/SB 342 (SO) by the Committee on Governmental Oversight and Accountability and Senator Harrell—

Public Records/Agency for Health Care Administration; Providing an exemption from public records requirements for the personal identifying and location information of certain current or former personnel of the Agency for Health Care Administration and the names and personal identifying and location information of the spouses and children of such personnel; providing for future legislative review and repeal of the exemption; providing for retroactive application of the exemption; providing a statement of public necessity, etc. Effective Date: 10/01/2025

Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Rules reports the committee substitute favorably

SB 302 (SO) by Senator Rouson—

Public Records/Judicial Qualifications Commission; Providing an exemption from public records requirements for the personal identifying and location information of current and former employees of the Judicial Qualifications Commission and the personal identifying and location information of the spouses and children of such employees; providing for legislative review and repeal of the exemption; providing for retroactive application of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules

CS/SB 300 (SO) by the Committee on Governmental Oversight and Accountability and Senator Rouson—

Public Records/Appellate Court Clerks and their Spouses and Children; Defining the term “appellate court”; providing an exemption from public records requirements for the personal identifying and location information of current appellate court clerks and the spouses and children of such appellate court clerks; providing for future legislative review and repeal of the exemption; providing a method for maintenance of an exemption; providing for retroactive application of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Rules reports the committee substitute favorably

CS/SB 202 (SO) by the Committee on Rules, Senator Jones and others—

Municipal Water and Sewer Utility Rates; Requiring a municipality to charge customers receiving its utility services in another municipality the same rates, fees, and charges as it charges consumers within its municipal boundaries under certain circumstances, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Regulated Industries; reported favorably by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

Similar to HB 11(HC) in the Committee on Rules

CS/CS/CS/SB 196 (SO) by the Committee on Rules, the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Regulated Industries, Senator Gruters and others—

Chemicals in Consumer Products; Revising the definition of the term “drug”; defining the term “vaccine or vaccine material”; requiring that, beginning on a specified date, cosmetics manufactured, sold, offered or distributed for sale, or distributed for use in this state provide notice of specified added ingredients on the single-use packaging of such cosmetics; deeming a food misbranded if it contains a vaccine or vaccine material, but its label does not include specified information, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 44 (SO) by the Committees on Rules, Transportation and Senator Rodriguez—

Motor Vehicles; Reclassifying the offense of driving, moving, or causing to be moved a vehicle or equipment with certain lighting on a highway as a third degree felony; prohibiting a person from knowingly using a license plate obscuring device; prohibiting the purchase, possession, manufacture, sale, offering for sale, or distribution of a license plate obscuring device, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; the Committee on Criminal Justice reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 253, 1st Eng.(HC) in the Committee on Rules

CS/CS/CS/SB 1828 (SO) by the Committees on Rules, Judiciary, Criminal Justice and Senator Martin—

Trespass; Providing enhanced criminal penalties for trespassing on property maintained or secured by federal, state, or local law enforcement officers if specified notice is posted; prohibiting a person from willfully entering or remaining in a venue during certain ticketed covered events without being authorized, licensed, or invited to enter or remain in such venue, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules

CS/SB 1820 (SO) by the Committee on Transportation and Senator Leek—

Motor Vehicle Manufacturers and Franchised Motor Vehicle Dealers; Prohibiting an applicant or a licensee, or a common entity thereof, from establishing, implementing, or enforcing certain criteria for measuring the sales or service performance of its franchised motor vehicle dealers unless certain conditions are met; revising the circumstances in which a discontinuation, cancellation, nonrenewal, modification, or replacement of a franchise agreement is deemed unfair, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; the Committee on Commerce and Tourism reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/CS/SB 1808 (SO) by the Committees on Rules, Health Policy and Senator Burton—

Refund of Overpayments Made by Patients; Requiring health care facility licensees to refund to the patient any overpayment within a specified timeframe; specifying that health care facility licensees who violate certain provisions are subject to administrative fines; requiring health care practitioners to refund to the patient any overpayment within a specified timeframe; revising the list of acts that constitute grounds for disciplinary actions for health care practitioners, etc. Effective Date: 01/01/2026

Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 1768 (SO) by the Committees on Rules, Health Policy and Senator Trumbull—

Stem Cell Therapy; Authorizing physicians to perform stem cell therapy not approved by the United States Food and Drug Administration under certain circumstances; requiring physicians to include a specified notice in any form of advertisement; requiring physicians to obtain a signed consent form from the patient or his or her representative before performing the therapy, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 1736 (SO) by the Appropriations Committee on Health and Human Services, the Committee on Children, Families, and Elder Affairs, Senator Grall and others—

Insulin Administration by Direct-support Professionals and Relatives; Defining the term “direct-support professional”; authorizing direct-support professionals and relatives of clients in group home facilities for individuals with developmental disabilities to administer insulin as prescribed to the client if specified conditions are met, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Rules reports the committee substitute favorably

Similar to CS/HB 1567(HC) in the Committee on Rules

CS/CS/CS/SB 1702 (SO) by the Committee on Rules, the Appropriations Committee on Pre-K - 12 Education, the Committee on Education Pre-K - 12 and Senator Burgess—

Education; Specifying sufficient notice and prior warning for immediate arrest and prosecution for school bus trespassing; authorizing a private school in a county that meets certain criteria to construct new facilities on certain property; requiring a charter school sponsor to use a standard monitoring tool to monitor and review a charter school; authorizing a student in a full-time virtual instruction program to participate on an interscholastic athletic team at a public school in the school district in which the student resides or to develop an agreement to participate at a private school; requiring the Commissioner of Education to coordinate with school districts selected by the department to implement a policy for a specified school year prohibiting the use of cell phones while on school grounds or engaged in certain activities off school grounds, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and reported favorably as a committee substitute by the Committee on Rules

CS/SB 1696 (SO) by the Committee on Rules and Senator Calatayud—

Prearranged Transportation Services; Prohibiting the impersonation of a transportation network company driver; providing that services purchased from a transportation network company are not considered privately owned or operated bus transit systems; requiring transportation service providers to provide certain drivers with access to certain training materials, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Transportation; reported favorably by the Committee on Criminal Justice; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 1525(HC) in the Committee on Rules

CS/CS/SB 1666 (SO) by the Committees on Rules, Commerce and Tourism and Senator Grall—

Uniform Commercial Code; Creating the “Uniform Commercial Code—Controllable Electronic Records”; specifying when a purchaser of a controllable account or controllable payment intangible is a qualifying purchaser; specifying when a person has control of a controllable electronic record; authorizing account debtors on a controllable account or controllable payment intangible to discharge obligations under certain circumstances; specifying requirements for perfecting security interests that are enforceable and perfected before a specified date, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Committee on Judiciary reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 515, 1st Eng.(HC) in the Committee on Rules

CS/CS/CS/SB 1662 (SO) by the Committee on Appropriations, the Appropriations Committee on Transportation, Tourism, and Economic Development, the Committee on Transportation and Senator Collins—

Transportation; Authorizing the Secretary of Transportation to appoint a specified number of assistant secretaries; creating the Florida Transportation Research Institute; providing that certain spaceport and space industry-related facility projects and commercial shipbuilding and manufacturing facility projects are eligible for grant funding under the Florida Seaport Transportation and Economic Development Program; authorizing the department, in consultation with the Department of Commerce and the Department of Environmental Protection, to fund certain infrastructure projects and projects associated with certain critical infrastructure projects; requiring airports to provide the Department of Transportation with the opportunity to use certain airport property for a specified purpose during a declared state of emergency; creating a rural transit operating block grant program to be administered by the department, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1652 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Judiciary, Senator Grall and others—

Public Records/Pleading, Request for Relief, or Other Document Stricken by a Court; Providing an exemption from public records requirements for a matter in a pleading, a request for relief, or other document which has been stricken by the court in a noncriminal case if the court makes specific findings; providing a statement of public necessity, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Judiciary; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Rules reports the committee substitute favorably

CS/CS/SB 1650 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Judiciary, Senator Grall and others—

Vexatious Litigants; Expanding actions subject to the Florida Vexatious Litigant Law; revising eligibility for designation as a vexatious litigant; prohibiting clerks of the court from accepting certain filings from a vexatious litigant, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Judiciary; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Rules reports the committee substitute favorably

Similar to CS/CS/HB 1559(HC) in the Committee on Rules

CS/SB 1644 (SO) by the Committee on Transportation and Senator Rodriguez—

Emergency Services; Deleting a limitation on the number of red or red and white warning signals that certain vehicles may display; revising the circumstances under which certain applicants for a specified license are exempt from a requirement to obtain certificates of public convenience and necessity; providing criminal penalties for the submission of an affidavit that fraudulently attests to certain facts; revising a limitation on the number of counties that may be granted a certain exemption, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/CS/SB 1640 (SO) by the Committees on Rules, Governmental Oversight and Accountability and Senator Grall—

Public Records/Lethality Assessment Forms; Providing an exemption from public records requirements for a lethality assessment form that contains certain information and responses; authorizing the disclosure of a lethality assessment form to a domestic violence center and to the office of the state attorney; providing for future legislative review and repeal of the exemption; providing for retroactive application of the exemption; providing a statement of public necessity, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 1624 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Higher Education and Senator Calatayud—
