## **HOUSE OFFER #1**

### **Implementing Bill - Update to State Group Insurance Health Assessment**

Update to language contained in HB 5003 - Section 46:

(1) In order to implement section 8 of the 2023-2024 General Appropriations Act, beginning July 1, 2023, and on the first of each month thereafter, the Department of Management Services shall assess an administrative health insurance assessment to each state agency equal to the employer's cost of individual employee health care coverage for each vacant position within such agency eligible for coverage through the Division of State Group Insurance. As used in this section, the term "state agency" means an agency within the State Personnel System, the Department of Lottery, the Justice Administrative Commission and all entities administratively housed in the Justice Administrative Commission, and the state courts system.

(2) Each state agency shall remit the assessed administrative health insurance assessment under subsection (1) to the State Employees Health Insurance Trust Fund, for the State Group Insurance Program, as provided in s. 110.123 and 110.1239, from currently allocated monies for salaries and benefits, within 30 days of receipt of the assessment from the Department of Management Services. Should any state agency become more than 60 days delinquent in payment of this obligation, the Department of Management Services shall certify to the Chief Financial Officer the amount due and the Chief Financial Officer shall transfer the amount due to the Department of Management Services. (3) The administrative health insurance assessment shall not apply to positions for which funding, or a portion of funding, is paid for with federal funds. Each state agency shall provide the Department of Management Services a complete list of position numbers that are funded, or partially funded, with federal funding no later than July 31, 2023, and shall update the list on the last day of each month thereafter. For federally funded positions, or partially funded positions, each state agency shall immediately take steps to include the administrative health insurance assessment in their indirect cost plan for 2024-2025 fiscal year and each year thereafter. A state agency shall notify the Department of Management Services upon approval of the updated indirect cost plan. If the state agency is not able to obtain approval from their federal awarding agency, they must notify the Department of Management Services no later than January 16, 2024. (4) Pursuant to the notice, review, and objection procedures of s. 216.177, Florida Statutes, the Executive Office of the Governor may transfer budget authority appropriated in the Salaries and Benefits appropriation category between agencies in order to align the appropriations granted with the assessments that must be paid by each agency to the Department of Management Services for the administrative health insurance assessment. This section expires July 1, 2024.
