The unexpended balance of funds on June 30, 2025, provided to the Department of Education in section 73 of chapter 2024- 231, Laws of Florida, for the Educational Stabilization Enrollment Program shall revert and is appropriated to the Department of Education for Fiscal Year 2025-2026 for the Family Empowerment Scholarship Stabilization Enrollment Program pursuant to section 1011.62(16), Florida Statutes, as created by CS/SB 7030 or similar legislation.
