RE: Office Suite Renovations Ground Floor Claude Pepper Building The Florida Senate

Dear Mr. Meyer,

We appreciate the opportunity to provide architectural services for the above referenced project. We understand that you would like to renovate existing office space on the Ground Floor of the Pepper Building. There are three areas to be renovated, Suite G24 and Conference Room G20 which are located on the east side of the building and Suites G50 and G60 which are located on the west side of the building. Renovations to these spaces include the following:

Scope of Work

G20 Conference Room (388sf):

New carpeting, ceiling, painting, lighting, TV monitors & smart boards.

G24 Office Suite (5,022sf):

New systems furniture, carpeting, ceiling, painting, lighting and installation of new Break Room.

G50 Computer Server Room & G50E Conference Room (477 sf):

New systems furniture, carpeting, ceiling, painting, lighting, TV monitors & smart boards.

G60 Office Suite (2,804 sf):

New systems furniture, carpeting, ceiling, painting, lighting and relocation of Break Room.

MEP renovations will include reuse of existing HVAC systems with modifications and additions of terminal boxes, ductwork, air devices and controls, plumbing design for new breakroom; modification of existing fire sprinkler branch piping and sprinkler heads; and power, lighting, fire alarm and IT/data/voice infrastructure modifications.

Our scope of work includes field investigation/verification of existing conditions, meetings to review the design, coordination with our engineers and construction manager, creation of construction documents and construction administration. We have discussed this project with Craig Allen of Pinnacle Engineering, Inc. and they will serve as our mechanical and electrical engineers for the project. Pinnacle has extensive experience working with DMS on state facilities and assisted Hicks Nation in the previous renovations of the Pepper Building.

We understand the Senate would like us to include additional time during the construction administration phase similar to the Senate Office Building renovation projects. We have included sufficient time for the design team to meet weekly during construction and also review the work on a weekly basis. A full time clerk-of-the works has not been included, but the more intense construction administration has been included as an additional service. We have included the Intensive Construction Administration in the Fee Summary.

We have reviewed the current bidding climate and estimate that the construction cost for the interior renovations is running around \$170/s.f. This includes the added cost for renovating space within the Capitol Complex. The estimated renovation cost for this project is as follows:

^{*}Probable Cost of Construction is for the building renovations only and does not include the cost of systems furniture and furnishings.

We propose to provide basic architectural and engineering services for the work described herein for a fee of \$128,830. This basic service is in line with the DMS fee curve for repairs and renovations Group "C" for the probable construction cost estimate of $1,477,470 \times 8.72\% = 128,830$. Additional service fees will be included as outlined above. A summary of the fees is included below.






OVERALL KEY PLAN | PLAN VIEW


