As will be more fully articulated in a Memorandum to be submitted tomorrow on the impact of the Scot Peterson arrest and prosecution, it appears likely that Sheriff Israel will learn of a number of previously unknown and unidentified material witnesses and evidence possessed by the Executive Branch in connection with the related criminal investigation of former BSO Deputy Peterson. Sheriff Israel and his legal team have been working industriously since last week's public revelation

of the charges to ascertain the case-impacting information gathered by Inspector Keith B. Riddick of the FDLE Office of Executive Investigations Public Corruption Unit. As soon as Sheriff Israel is able to fully articulate specific witnesses by name and documents by description, Sheriff Israel will present his supplemental list of witnesses and exhibits needed to protect his fundamental right to due process in these proceedings.

Also, Sheriff Israel clarifies that his Exhibit 25 (SaferWatch App) is being accessed and will be made a part of the Exhibit DropBox tonight.
