The Executive Office of Governor Ron DeSantis intends to show that Mary Beth Jackson, as the Superintendent of Okaloosa County School District, had certain statutory duties and responsibilities. The exhibits will show that starting in February 2016, reports of alleged child abuse were known to Mary Beth Jackson and she did not follow her statutory responsibilities. The exhibits will also show a lack of education and training for the faculty and staff members within the school district, which led to a failure to report suspected child abuse to Department of Child & Families. The School District polices will show deficiencies in policy to notify the parents of any child who was suspected to have been abused. Furthermore, the exhibits will show that Mary Beth Jackson knew or should have known about the suspected child abuse and failure to report child abuse, but failed to take any appropriate action against the teacher or fix the deficiencies until the summer of 2017, once a criminal investigation was initiated. The exhibits will show that even though it was recommended that a teacher be referred to the Florida Department of Education's ("DOE") Office of Professional Practices in June 2016, Mary Beth Jackson recommended no discipline and failed to notify DOE about the allegations. Finally, the exhibits will show that the issues at Okaloosa County School District rose to the level of criminal conduct, and that as late as Fall 2018 there were still issues with child abuse and failure to report suspected child abuse in the school district.
